INDEPENDENT INSPECTION AND AUDIT REPORT

In accordance with your instructions we have performed an independent audit on "Korloff investment diamonds" held by AuCOFFRE.com on behalf of VERACASH. AuCOFFRE is the unique provider for VeraCash, its affiliate. Therefore, all VeraCash products are kept by AuCOFFRE and in AuCOFFRE's safes. Our findings are as follows:

Principle

The principle of this audit was to confirm that diamonds stored by AuCOFFRE.com, on behalf of VERACASH, are physically present in their specified vault and correspond to their individual specifications.

Aim

To provide total reassurance to members that the diamonds exist and are stored correctly in a suitable environment to ensure maximum security and ideal conditions of conservation that maintain the quality and condition of items stored.



The Vaults / Storage

Situated in the Geneva Freeport secure facility they contain a variety of diamonds, gold bullion, silver bullion, gold coins and silver coins which are stored on behalf of members.

Access to the vaults is strictly controlled by on site security systems. Only verified staff members are allowed entry and visits need to be planned to make the necessary security arrangements.

The vaults are under permanent video & electronic surveillance as well as human guards.

Within the vaults the diamonds were stored in a protective box and were also individually packaged with their information enclosed. Certificates for each diamond are also stored along with the diamonds.

The Method

The audit took place in AuCoffre's Vault.

During the 2017 audit, auditors were provided with a full stock list of the stored diamonds which listed information such as Origin, Certificate Number, Carat, Colour, Clarity etc.

During the 2017 audit, the diamonds were individually counted, and the total number identified was found to correspond with the advised list.

Total advised weight of diamonds was 103.8 which was subdivided into four batches as below:

- Batch N° 1 : 26.65 carats - 33 diamonds advised
- Batch N° 2 : 25.44 carats - 30 diamonds advised
- Batch N° 3 : 26.65 carats - 31 diamonds advised
- Batch N° 4 : 25.06 carats - 33 diamonds advised

The auditors sealed each of the 4 boxes using tamper proof tape marked with an individual seal number. On subsequent audits two boxes had been checked and resealed with ALS tamper proof tape seal. All seals were still found to be intact when the boxes were checked in 2024.

The above report reflects our findings at the time and place of the inspection only and does not refer to any other matters.
